



## EDAMA Plays a Leading Role in Establishing a Joint Technical Committee on Energy Storage and Electricity Regulation

EDAMA engaged with key regulatory and legislative authorities in Jordan to discuss the development of energy storage systems and recent updates to electricity sector regulations. These engagements included the establishment of a joint technical committee with the Energy and Minerals Regulatory Commission on June 18, tasked with examining technical aspects of energy storage, grid stability, and tariff structures. Following the committee's first meeting on July 17, a draft Memorandum of Understanding (MoU) was prepared to establish a framework for institutional collaboration within Jordan's energy sector.

In parallel, EDAMA briefed the Parliament's Energy Committee on challenges facing renewable energy companies, including regulatory changes and licensing fees. EDAMA also submitted recommendations on draft electricity regulations to support sector sustainability and enhance regulatory clarity. Collectively, these activities demonstrate EDAMA's ongoing role in facilitating dialogue between the private sector, regulators, and policymakers to address energy sector challenges and support effective policy development.



### Gender Task Force

The project aimed to strengthen gender equality and enhance women's participation in Jordan's energy sector through evidence-based analysis and structured dialogue.

It combined a national gender assessment with multi-stakeholder engagement activities involving public institutions, the private sector, academia, civil society, and women professionals.

The process identified policy gaps and sector challenges, which were analyzed and prioritized through facilitated workshops.

Participants co-developed practical, policy-aligned tools and recommendations, validated through a technical roundtable.

The project delivered actionable outputs to support improved policy implementation and institutional practices in the energy sector.

### Circularity Hub for Spent EV Batteries

The Circularity Hub (C-Hub) was launched on November 5, 2023, at the German Jordanian University (GJU) in collaboration with the EDAMA Association, with support from the German Agency for International Cooperation (GIZ) through the Green Action in Enterprises (GAIN) project. As the first initiative of its kind in Jordan, the C-Hub focuses on the sustainable end-of-life management of electric vehicle (EV) batteries.

The C-Hub aims to establish a robust ecosystem for the sustainable management of EV batteries by fostering collaboration among public, private, and academic stakeholders, thereby strengthening Jordan's role in the circular economy. In addition, the hub supports applied research and innovation in battery recycling, contributing to the development of technical skills and local capacities essential for long-term sustainability.

## CONTINUED PROJECTS

### Mediterranean Waste Innovations for Sustainable Environments (MEDWISE)

The project strengthens research and innovation in the Mediterranean region by supporting advanced waste management technologies and fostering cross-border academic, research, and business collaboration through technology transfer and knowledge exchange.

The Mediterranean grapples with waste management issues, with most municipal waste ending up in landfills untreated. Organic waste, a major component and a valuable source of energy and nutrients, is often contaminated, rendering it inadequate for use. Although a circular economy is needed to address this, the region faces inconsistent variations in legislative, technical, and funding gaps that hinder the implementation of circular strategies.
